Introduction

Kentucky's commercial feed law (KRS 250.491-250.631) dates from 1906 and was last revised in 1996. This feed law provides protection for the state's livestock. poultry, and pet owners by regulating all feed materials offered for sale or for mixing into a feed. Products falling under regulation include all types of pet foods, livestock minerals, complete animal and poultry feeds, protein or mineral blocks, supplements, feed ingredients, specialty materials such as drug premixes, vitamin and mineral supplements, liquid feeds, pet supplements, pet treats, and other specialized pet foods. The law does provide for exemptions for whole and unprocessed grain, raw meat, hay, straw, stover, silage, cobs, husks, and hulls when not processed. Revisions in law and regulations are primarily in response to more varied livestock feeding practices, changes in feed manufacturing technology, and new feed ingredients. Our regulations were last revised in 2018 to better align with the American Association of Feed Control Officials (AAFCO) model bill and regulations. In the coming year, we will be revising our regulations to adopt AAFCO's Pet Food Label Modernization regulations.

Information in this report is intended to inform the feed purchaser, provide a basis for fair and equitable competition, and assist in assuring the safety of animal and human food.

Feed Mill Inspections

Maintaining high quality and safe feeds for animals requires a comprehensive inspection program. Mills may be required to obtain a license from the Food and Drug Administration (FDA) to manufacture medicated feed, depending on the type and concentration of drug. There are eight feed mills in Kentucky with a feed mill license (FML) from the FDA and 44 mills in the state manufacturing medicated feed

but not requiring a license from FDA. All feed mills must comply with good manufacturing practices assessed as part of a comprehensive inspection program. The purpose of these inspections is to ensure several safe feed practices are as follows: (1) approved drug levels are used, (2) proper mixing procedures followed, (3) feed ingredients monitored, (4) good record keeping followed, (5) good housekeeping protocols followed, and (6) a recall plan in place.

The Division participates in an inspection program in partnership with FDA that conducts inspections of facilities manufacturing and distributing animal feed. In recent years, our inspection program has evolved to include more inspections involving two inspectors, a greater focus on manufacturers, and the addition of new inspections to evaluate progress of firms in meeting Food Safety Modernization Act (FSMA) requirements. Inspections to determine compliance with the rules in place to prevent the establishment and amplification of Bovine Spongiform Encephalopathy (BSE) are now limited to firms that manufacture feeds containing ruminant protein products. Our division continues to encourage compliance by Kentucky feed distributors with the Veterinary Feed Directive (VFD) rules that went into effect in 2017. Inspections at medicated feed mills include a review and evaluation of VFD records if the firm is a manufacturer of these feeds.

Ourinspectors conducted 30 inspections in 2024 spanning the 2023-24 and 2024-25 contracts with FDA. Our inspection contract includes evaluations of good manufacturing practices (GMPs) at 32 Kentucky mills annually with around half of these facilities manufacturing medicated feed. With FSMA regulations now including production of non-medicated feed, we are committed to conducting inspections for compliance with FSMA regulations at all Kentucky feed manufacturers in the next few years. To date, we have inspected 98% of Kentucky

feed manufacturers on our inspection list for compliance with FSMA regulations. The contract also includes preventative controls inspections at 15 of the 32 total inspection locations. All facilities manufacturing animal feed are subject to FSMA cGMP regulations but only around 45% of Kentucky manufacturers fall under the regulations covering preventative controls. At the end of 2024, there were 181 feed manufacturing facilities located in Kentucky that serve the animal feed and pet food

industries. Of these 181 feed manufacturers, 132 facilities would fall under our inspection inventory. Beverage distilleries and other manufacturers subject to CFR 21 Part 117 (human food regulations) are not inspected under our authority. Additionally, 345 feed distributors located in the state handle livestock feed. Animal feed distributors are subject to the portions of CFR 21 Part 507 regulations that apply to holding and distributing feed.

Food Safety

The goal of the Food Safety Modernization Act (FSMA), enacted in 2011, is to ensure the safety of the US food supply by shifting the focus of federal regulation from responding to contamination to preventing it. All facilities manufacturing or holding animal feed are required to comply with good manufacturing practices and preventative controls are required for eligible facilities. We continue to closely monitor the manufacture of medicated animal feed as our inspection program evolves to be more in line with FSMA philosophy. Our focus on educating before regulating will remain in place.

While preventing feed related problems is the best approach, there will continue to be occurrences with animal or pet food that need attention including abnormal feed color or odor, presence of a foreign material, animals refusing the feed, and sickness or death of animals. An investigation is warranted when any of these occur. Regulatory Services works in conjunction with the University of Kentucky Veterinary

Diagnostic Laboratory, extension agents, local veterinarians, feed dealers, and feed manufacturers, and take samples of feed when these incidences occur. Our continued emphasis on frequent inspections, regular sampling, laboratory analysis, label reviews, and inspections support efforts to maintain food safety and minimize any adverse impact.

Since September 2016, Kentucky has been one of a group of now 25 states participating in the Animal Feed Regulatory Program Standards (AFRPS) initiative, a joint effort by the American Association of Feed Control Officials (AAFCO) and the FDA to help build a more robust integrated food safety system by concentrating on regulation of animal feed production. Kentucky has fully implemented each of the 11 standards. From 2016 through June 2025, this cooperative agreement brought over \$4,500,000 into the division and the university. Implementation of these standards has strengthened our program and provided a defensible, sustainable pathway forward.

Feed Registration and Labeling

Manufacturers are required to register all feeds before distribution to ensure that correct label information is provided to the purchaser. Each year, we conduct more than 7.000 label reviews for products for animals or pets. Guaranteed analysis, ingredient listings, and feeding directions for the intended animals or pets are scrutinized. Particular attention is given to medicated feed labels with regards to approved drug usage and dosage, statement of drug purpose, and any required warning, caution, or special feeding instructions. Misleading and unsubstantiated information or claims are prohibited. Over 23,000 different commercial feeds and pet foods are registered for distribution by nearly 1,500 companies. More than half of these registered products are in the pet and specialty categories.

A feed label is the fundamental communication with the consumer; it provides purpose of the feed, directions for use, nutrient information, ingredient content, and special comments or warnings. Providing labeling assistance and guidance to product registrants and manufacturers has been beneficial in attaining high quality feeds and promoting food safety. Our full-

time registration specialist reviews product labels for compliance with applicable laws and regulations. The field inspectors assist manufacturers with labeling, resulting in more uniform and informative labels. Additionally, spreadsheets are available to assist in establishing label guarantees and for estimating nutritional suitability of custom mixed feeds and even pet treats. These services strengthen an excellent working relationship with the feed industry in Kentucky.

AAFCO's pet food label modernization represents a major change in how pet foods will be labeled in the future. The goal of the updated pet food regulations is to provide consumers with labeling information that is transparent, easy to understand, and in a more familiar format. Pet nutritional information will be presented in a "nutrition facts box" format to more closely resemble human food labeling. In addition, the calorie content of the pet food will break down calories from protein, fat, and carbohydrates. Nutrients will be guaranteed using common household measurements, such as a cup. or in other easily defined amounts. The guarantees are being updated to include total carbohydrate and dietary fiber, which

are more relevant measurements of fiber than the previously required crude fiber. Though our regulations will be changed in 2025, we expect the transition to the new label format will require a few years and will allow pet food companies time to comply with these regulations.

Financial Support

The feed regulatory program is supported by inspection fees of the commercial feeds sold in Kentucky, registration fees for small package items, and General Assembly appropriated funds. An inspection fee of 35 cents per ton is paid on commercial feeds in packages of larger than 10 pounds. Distiller's wet grains, other distillers products of more than 75% moisture, whey and brewers wet grains distributed without further processing pay a fee of 5 cents per ton. Products sold exclusively in packages of 10 pounds or less pay an annual registration fee of \$50 per product. In 2024, net income for the feed program was \$1,620,483 including inspection fees, registration fees and late payment penalties.

Feed Sampling

For tables 1-3, we report both official samples with label guarantees and other samples. Official samples are those collected by our inspectors under guidelines specified by our sampling protocols. Other samples reported include unofficial samples, samples without label quarantees, lab proficiency samples, and service samples. Tables 1, 2, and 3 list the number of samples of feed ingredients, commercial feeds, and pet/specialty foods received by our lab in 2024. Most of the ingredients sampled continue to be corn grain, corn protein feed (formerly corn gluten feed), distiller's grains, soybean meal, and soy hulls. Beef, poultry, and equine feed were the largest categories of commercial animal feed excluding pet food. Pet and specialty foods accounted for 40% of all official samples with guarantees.

In addition to the 2,766 official samples reported, our lab also analyzed an additional 407 other samples. The samples include samples lacking guarantees collected by inspectors (primarily corn), ingredients and

products submitted to our lab by county extension agents, the UK Veterinary Diagnostic Laboratory, livestock producers, and consumers. In 2024, our lab analyzed 182 service samples for Kentucky feed consumers, feed dealers, and manufacturers and 30 research samples.

Corn Quality Survey

Each fall, our inspectors collect corn samples from elevators and feed mills as new crop corn makes its way into the market. A total of 90 samples were tested for crude protein, crude fat, fiber, and moisture and 55 samples were screened for mycotoxins. We did not find evidence of major mycotoxin issues with this year's crop (Table 4). Crude protein averaged 7.1% on the samples in this year's survey.

Feed Analysis

Analyses of nutrients and other components in feed samples are provided by our feed laboratory. The laboratory data are used to evaluate suitability of product labeling, feed quality, and absence of any contaminants or deleterious substances. Table 5 reports the number of feed analyses conducted on samples during 2024. Our sample report table by manufacturer or guarantor includes only official samples with guaranteed tests. However, results of testing for non-guaranteed analytes are also listed in sample reports to provide more information to the manufacturer/guarantor.

Our lab conducted mycotoxin tests on 76 samples in 2024. Most of these tests were conducted on corn with additional tests on samples analyzed during investigations into product quality and/or animal health issues. A total of 142 samples were analyzed for medication levels in 2024.

The use of NIR (near infrared reflectance spectroscopy) as a screening tool with livestock feeds, ingredients, pet foods, pet treats, and specialty products continues to play an important role in our laboratory.

If the NIR scan indicates the sample does not meet the guarantee of the analyte in question or the NIR value is questionable, the sample is analyzed by the appropriate wet chemistry method. As a screening test, we do not issue violations based solely on the NIR estimate. Analysis of minerals and medications continues via traditional wet chemistry methods. For sample reports, we report which analytes were estimated using NIR. NIR also has allowed the reporting of analytes that we do not typically measure in some feed types (for example, crude fat and crude fiber in poultry and swine feeds). For our lab, the advantages of using NIR as a screening test include both the speed of analysis with results available in less time and lower cost in both lab reagents and labor.

Tonnage Distribution

Tables 6 and 7 use data collected from the Kentucky Feed Tonnage Reports submitted by firms distributing feed products in the state. Table 6 reports ingredients and Table 7 reports commercial feeds. The term "exempt" represents ingredients sold to other feed manufacturers in Kentucky who pay the inspection fees. "Non-exempt" represents ingredients in which the reporting firm pays the inspection fee.

At 2.5 million tons, the total ingredients and commercial feeds distributed reported in 2024 was a little below 2023 volume of 2.59 million tones. Beef, poultry, equine, and dairy continue to be the largest volume categories of non-pet food commercial feed in distribution. These four categories accounted for 67% of total tons reported this year. Pet food volume accounted for 21% of total tons reported in 2024.

Analytical Variations

Regulatory officials use analytical variations (AVs) as a guide for issuing any type of violation of the label guarantee. The total variation surrounding an analytical analysis

of a feed product and comparing it to a label consists of (1) variation associated with the formulation and mixing in producing a feed, (2) variation of particle sizes in feed ingredients, (3) potential ingredient settling during transport, (4) variation associated with sampling, (5) variation associated with mixing and grinding samples, and (6) variation during analysis in the laboratory. Most variations associated with sampling, mixing, grinding, and analysis in the laboratory are known through of many years of study to arrive at Official Methods. The AVs listed in Table 8 allow for the inherent variability in sources that follow the Official Methods, with more weight given to the areas of analytical variation. The laboratory reported value of an analyte in a sample is reviewed with respect to the quarantee using the AVs below as a guide. Our AV table is referenced in our regulations (12 KAR 2:021).

Note that the AVs listed for minerals do not apply to cat and dog complete foods formulated to meet Association of American Feed Control Officials (AAFCO) requirements. These complete pet foods must meet AAFCO pet food profiles. All profiles have minimum mineral requirements and some have maximums as well. In this case, the tolerances are national standards set by AAFCO.

Sampling Location Report

Table 9 contains a list of all Kentucky locations where inspectors collected samples in 2024. Samples were collected at 322 locations with a total of 634 feed sampling visits in 2024.

Sample Violation Report

The sample violation report for 2024 (Table 10) includes the 2,766 official samples from 468 different manufacturers or quarantors. Overall, 77.4% of samples passed (no violations on any analytes) while 96% of all analytes met their label quarantees. When label violations are found, manufacturers or quarantors are requested to investigate and report their findings to the feed director. When violations have the potential to harm animals or consumers, our office has the authority to with draw the product fromdistribution until the problem is corrected. For the last few years, our office has issued withdrawals from distribution for "major violations" when samples fail to meet guarantees for medications (deficient or excessive), selenium (deficient or excessive), copper (excessive), salt (excessive), and non-protein nitrogen (excessive). In 2024, our office issued 47 withdrawal from distribution orders after identifying major violations in products sampled (7.5% of all violative samples). The response rate from guarantors to violations has improved over the last 3 years. In 2024, we received responses to 63% of all violations and 70% of all major violations.
